**HIGH PERFORMANCE MOTORCYCLE RIDING IS DANGEROUS.**

EVERY PARTICIPANT ASSUMES BY HIS/ HER PARTICIPATION RESPONSIBILITY FOR ALL RISKS OF RIDING AND/OR COMPETITION INCLUDING INJURY OR DEATH. EVERY RIDER ASSUMES BY HIS/HER PARTICIPATION THE RESPONSIBILITY AND OBLIGATION TO ASSESS THE SAFETY ASPECTS OF FACILITIES AND INDIVIDUAL CONDITIONS AND MUST ASSUME ALL RISKS OF RIDING ON A RACETRACK, INCLUDING INJURY OR DEATH.

IN CONSIDERATION (a) of being permitted to study, train, compete, officiate, observe, work for, or participate in any way in the Event(s) or (b) being permitted to enter, for any purpose, any Restricted Area (defined as any restricted area requiring special authorization, credentials, or permission to enter any area where admission by general public is restricted or prohibited), including but not limited to, the training area, the surrounding undeveloped area and the competition area. THE UNDERSIGNED, for himself/herself, his/her personal representatives, parent or legal guardian, heirs, and next of kin:

1. Acknowledges, agrees, and represents that he/she has WILLINGLY AND KNOWINGLY DECIDED TO PARTICIPATE IN THE EVENT(S) WITHOUT HAVING PERSONAL MEDICAL INSURANCE COVERAGE. He/she fully understands that should he/she have any loss or damage, including claims or demands on account of injury to the person or property, or as a result of death, that he/she is fully responsible for all loss or damage, including all medical bills and disability claims, and understands that it may fully exhaust all of his/her financial means. The undersigned ACKNOWLEDGES THAT HE/SHE IS AWARE THAT CORNERSPEED, INC. D/B/A CORNERSPIN AND/OR CORNERSPEED RIDERSCHOOLS AND K&K INSURANCE DO NOT OFFER OR SUPPLY ANY MEDICAL COVERAGE WHATSOEVER FOR THIS EVENT(S).

2. HEREBY RELEASE, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE Cornerspeed Inc. d/b/a Cornerspin and/or Cornerspeed Riderschools, K&K Insurance, the Rider's School instructors, all associate instructors, the participants, the promoters, the owners and lessees of the premises, and its affiliates and related companies, officers and employees, and those in privity with them including without limitation any co-promoters, racing associations, sanctioning organizations or any subdivision thereof, including any parents or affiliated entities, track operators, track owners, officials, car owners, drivers, pit crews, rescue personnel, medical personnel, any persons in any Restricted Area, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the Event(s), premises and event inspectors, surveyors, underwriters, consultants and others who provide recommendations, directions, or instructions including, but not limited to, driving schools or classes or engage in risk evaluation or loss control activities regarding the premises or Event(s) and each of them, their directors, officers, agents and employees, all for the purposes herein referred to as "Releasees" FROM ALL LIABILITY TO THE UNDERSIGNED, his personal representatives, parent or legal guardian, assigns, heirs, and the next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFORE ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY, OR RESULTING IN DEATH, TO THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENT(S), WHETHER CAUSED, IN WHOLE OR IN PART, BY THE SOLE OR CONCURRENT NEGLIGENCE OF WRONGDOING, STRICT LIABILITY OR FAULT OF THE RELEASEES OR OTHERWISE.

3. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releasees and each of them FROM ANY LOSS, LIABILITY, DAMAGE OR COST they may incur arising out of or related to the Event(s) WHETHER CAUSED BY THE SOLE OR CONCURRENT NEGLIGENCE, STRICT LIABILITY, OR FAULT OF THE RELEASEES OR OTHERWISE.

4. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the Event(s) WHETHER CAUSED BY THE SOLE OR CONCURRENT NEGLIGENCE OF RELEASEES OR OTHERWISE.

5. HEREBY acknowledges, that THE ACTIVITIES OF THE EVENT(S) ARE VERY DANGEROUS and involve the risk of serious injury and/or death and/or property damage. Each of THE UNDERSIGNED also expressly acknowledges the INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES. The UNDERSIGNED authorize and provide full consent to Cornerspeed Inc. d/b/a Cornerspin and/or Cornerspeed Riderschools, its subsidiaries, affiliates, agents, contractors, vendors, track operators, volunteers or others, subject to the release, waivers and indemnities contained herein, to seek and/or provide medical attention/treatment, including the release and distribution of medical records, the respective entities may deem necessary and appropriate, in the event the undersigned is unable, unfit or not qualified to make such decisions.

6. HEREBY agrees that this Release and Waiver of Liability, Assumption of Risk, Indemnity and Rights Agreements extends to all acts of negligence or wrongdoing by the Releasees, INCLUDING NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by the laws of the Province or State in which the Event(s) is/are conducted and that if any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

**I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OR RISK, INDEMNITY AND RIGHTS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I GIVE UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.**
